## Longtime Uniland tenant Lornamead to expand oral care production and distribution facility in Tonawanda

**TONAWANDA, N.Y. When completed, the 88,000 SF facility in Uniland's Interstate Commerce Centre will support Lornamead's growing oral care production and distribution operations. The addition will allow for greater inventory control and warehouse distribution as well as enhanced manufacturing technology to support expanding levels of production and distribution.

Lornamead's expansion reflects the growing business in oral care segments including toothpaste, tooth whitening gels and oral pain relief treatments. The company sells products under its own brands, as well as manufacturing for retailers and other brand owners. According to Lornamead, the facility has delivered double-digit output growth over the past three years.
